## **ADOPTION OF PRELIMINARY BUDGET 2021-22**

Those in Attendance: Mayor Rivers, Councilmember Mary Berry, Councilmember LaRita McCallum, Town Manager George, Town Clerk Ruise, Administrative Assistant Williams.

Meeting began at 6:30pm discussing the Preliminary Budget and Millage Rate.

Mayor Rivers, Town Manager George and the Town Council actively discussed the budget and millage rate. It was decided to set the millage rate at 6.0%. The county will give the town the actual millage rate.

Councilmember Mary Berry made the motion to adopt the Preliminary Budget and the Millage Rate at 6.0%. The motion was seconded by Councilmember LaRita McCallum. The motion passed 3-0.


